**Courses:** We will hold a 5K Walk/Run and 10K Run through the beautiful back roads of rural Mississippi, followed by a pancake and sausage breakfast for all participants.

**Time & Place:** Race Day Registration at 7:00 am, Henleyfield Community Center (Hwy 43 and Henleyfield-McNeill Rd.) Race starts at 8:00 am.



**Directions:** We're about 15 miles NW of Picayune MS. From I59, take Exit 15 (McNeill) turn west (left coming from NO) onto the Henleyfield-McNeill Rd. Continue 11.5 miles to the stop sign at Hwy 43. Turn left. The Community Center will be on your immediate right.

All proceeds will go towards improvements to the multi-purpose Community Center.
